Cyber Incident

February 23, 2025, there was a Cyber incident that temporarily shut down our operations until March 11, 2025.

The City of Cleveland's IT came to assist with the breach along with the Ohio National Guard as we were moved from an on-site operation to the Disaster Recovery Cloud (DRC) .

The DRC offered limited services and severely impacted our ability to serve and work at the same level we previously did

We transitioned out of the DRC to a regular cloud January 24, 2026,

97% of our employees completed Cyber Security training for State compliance

Collections for moving violations

House Bill 29 - license suspensions

Effective April 9, 2025

Originally intended to help people who pay child support with suspended licenses who needed their license to work (or transportation)

Cleveland Municipal Court has nothing to do with child support

The Bill no longer allow registration holds for people with unpaid fines

Registration holds only affect the car, not the license i.e. tags, stickers, plates, transfer of title, etc.

Impact: Took the teeth out of collections for all of the Clerk's offices in the State of Ohio

Collections for moving violations

House Bill 29 - license suspensions (cont.)

- Crippled the collection efforts by no longer allowing registration holds for people with unpaid fines
- Only allow Registration holds for individuals who fail to appear in court (FTA)
- Alliance One is our collection agency
- Attorney General's Office will be our primary source for collections
 - Any income reviewed by the State i.e., state income taxes, lottery winnings

AI for the Clerk of Courts

- Last year our administrative staff and management team began the conversation about AI, and where if at all, it would fit in the Clerk of Courts office
- We are cautiously learning about AI
- Consulting with the National Center of State Courts to get guidance on Governance Rules
- We will not use AI to replace employees rather make them more efficient
- Our first AI project will be electronic-filing which will streamline the intake filing process



E-Filing Highlight: 58.7% of Contract Cases were E-Filed

ESSENTIAL YEARLY STATISTICS 2025

- **Contract cases:** 7,236 (+550 from 2024)
- **Contract cases E-Filed:** 4,249 (58.7% contract cases)
- **Housing evictions:** 5,977 (+ 114 from 2024)
- **Rent Deposit cases:** 112 (-31 from 2024)
- **Marriages performed:** 693 (+42 from 2024)
- **Small Claims cases** 1,086 (+212 from 2024)
- **Total case count:** 20,538 (+1,926 from 2024)

- Operates 24/7, including holidays
- Services Include:
 - Posting Bonds
 - Rescheduling Court Dates
 - Payments for waivers/fines

Online Services

- Available 24/7
 - Features:
 - Plead Not Guilty online
 - Plead Guilty with No Points for minor misdemeanor offenses (Stop Sign etc.)

Criminal Division Call Center

- 42,085 calls handled in 2025
- Spanish-language support available
- 1,266 over the phone payments processed
- Increase in warrant verification calls:
 - 30+ additional calls/day from Radio Bureau of Communications

Subpoenas & Summons

- Subpoenas issued: 14,501
- Summons issued: 14,110
- Ensuring court appearances for law enforcement officers, victims, witnesses and defendants

Impact of House Bill 29

- Certified mail requirements increased dramatically:
 - 2024: 4,823 mailings (\$33,603.82)
 - 2025: 12,629 mailings (\$104,247.50)

Process improvement

- Collaboration with Jail Liaison, Cleveland Division Police and Cuyahoga County Jail
- New warrant verification process:
 - Real-time radio transmissions from the Bureau of Communications
 - Email Warrant Verification Form to all departments
 - Result: Faster booking and improved efficiency





**Cleveland Municipal Court
Clerk of Courts**



- We go into Neighborhoods (Churches, Community Centers)
- We help people who have warrants or holds blocking them from getting license tags, jobs, apartments (traffic, non-violent misdemeanors)
- We put them on payment plans or schedule them for court



Agreements with Courts (Cleveland /Suburbs)

- **If person has traffic or non-violent misdemeanor warrant**
- **If they come to court when we schedule them**
- **They will not be arrested (held) even if they have a bond**
- **They will be put on a payment plan (Comm. Work Service)**
- **Warrant lifted**
